High School students must have completed their junior year before applying to the Wright Path, and current Clark State College students must have a minimum 2.0 GPA.

## ***Transfer to Wright State University***

Students must earn a minimum 2.0 GPA from Clark State College in order to transfer to Wright State.

Wright State processes applications as they are received. To help you make a smooth and timely transition, we recommend you submit your application by the following dates:

Fall Semester:	<b>April 1</b>
Spring Semester:	<b>October 15</b>
Summer Semester:	<b>February 1</b>

Students must apply to the Undergraduate Admission one semester prior to completing their studies at Clark State College.

In order to be admitted fully as a business major at Wright State, students will need to achieve a cumulative GPA of a 2.5. In addition, they must complete the following equivalent Wright State courses prior to transfer: ENG 1100, ENG 2100, ACC 2010, ACC 2020, EC 2040, EC 2050, FIN 2210, MKT 2500, MS 2040, MS 2050, and MTH 2280.

Students interested in the Accountancy major are strongly recommended to earn a minimum grade of C in ACC 1100 and ACC 1200 at Clark State College.
