This document is an Addendum to the Articulation Agreement between Bowling Green State University ("BGSU"), with an address of 1600 East Wooster Street, Bowling Green, OH 43403; and Clark State Community College with an address of 570 E. Leffel Lane, P.O. Box 570, Springfield, Ohio 45501.

The Addendum serves as an extension of the original Articulation Agreement between BGSU and Clark State Community College, which was approved by both institutions and signed February 2013. Furthermore, this Addendum will extend the original Articulation Agreement, with no modifications or changes, for an additional five year period.

The original Articulation Agreement was executed in order to facilitate credit transfer and provide a seamless transition between the two institutions for students planning to earn a four-year degree. The Addendum extends the intent and spirit of that arrangement based upon the following rationale.

BGSU and Clark State Community College agree to extend the Articulation Agreement by means of this Addendum effective this July 1, 2015 for a five-year period ending June 30, 2020; IN WITNESS WHEREOF, the parties have executed this Addendum as of the current date just indicated.
