

# Board of Trustees Reorganization Meeting

# MINUTES January 17, 2023

The Clark State College Board of Trustees met in special session in the Sara T. Landess Technology and Learning Center Boardroom with the majority of guests attending virtually via Zoom due to the COVID-19 pandemic on January 17, 2023. # Oath of Office

There being no unfinished business, Trustee McDorman made a motion to adjourn from 2022 business sine die. Vice Chair Ball seconded, and the motion passed unanimously via a roll call vote.

#### Election of Officers/Appointments

Trustee Noonan reported that the Nominating Committee met in October and would like to nominate David Ball step into the Chair position, Sharon Evans assumes the role of Vice Chair, Dr. Blondin remain as Secretary, and Doug Schantz remain as Treasurer.

Trustee Hall congratulated Chair Ball on his new position and invited him to conduct the remainder of the meeting.

At this time, Dr. Blondin presented Trustee Hall with a gavel plaque as a token of appreciation. She expressed gratitude for the leadership he has shown during his time as Chair and for his constant focus on our students, faculty and staff, as well as his work on Achieving the Dream, his excellent representation of Champaign County, and the instrumental role he played in our progress in manufacturing.
