Degree/Program: Associate of Applied Science (AAS) / Criminal Justice Technology-Law Enforcement

Target Institution: University of Cincinnati / College of Education, Criminal Justice, & Human Services

Degree/Program: Bachelor of Science (BS) / Criminal Justice (On-Campus & Online)

Introduction: This agreement details the applicability of courses from the Clark State College AAS Criminal Justice Technology-Law Enforcement to the BS Criminal Justice in the College of Education, Criminal Justice, & Human Services. Students who complete the AAS Criminal Justice Technology-Law Enforcement at Clark State College have satisfied the UC General Education requirement.

Articulation Overview: Graduates from Clark State College who have followed the prescribed program and are accepted into the College of Education, Criminal Justice, & Human Services will enter with 62 hours of transfer credit applicable toward the BS Criminal Justice degree.

Admission Criteria: *Note: completing the courses on the appendices below does not guarantee admission to the UC BS Criminal Justice program.

Minimum GPA: 2.0

BS Completion: Completion of this program may require more than four semesters to complete due to prerequisite requirements and the order in which required courses must be taken and are offered. UC academic advising staff will work with each transfer student to develop the most expedient pathway to graduation.

Admission Period: Clark State College students must be admitted to the UC College of Education, Criminal Justice, & Human Services during the duration of this agreement (i.e. between May 1, 2024 and July 31, 2027).

Agreement Execution Date: May 1, 2024

Agreement End Date: July 31, 2027

EXECUTION, DURATION AND REVIEW OF AGREEMENT:

This agreement becomes effective upon its signing by the Deans of both Colleges and will remain effective for the duration outlined above. At the end of this time, the agreement will be reviewed and may be renegotiated. Clark State College and the UC College of Education, Criminal Justice, & Human Services agree to keep one another informed as program changes affecting the agreement occur. The Deans of both Colleges will agree upon any future additions and/or amendments to this document in writing.

This agreement will be reviewed on an annual basis and is subject to change due to revisions in program curriculum.

Clark State College students are encouraged to work closely with their academic advisor to monitor possible changes.



ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, The University of Cincinnati (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through your DocuSign, Inc. (DocuSign) Express user account. Please read the information below carefully and thoroughly, and if you can access this information electronically to your satisfaction and agree to these terms and conditions, please confirm your agreement by clicking the 'I agree' button at the bottom of this document.

Getting paper copies

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. For such copies, as long as you are an authorized user of the DocuSign system you will have the ability to download and print any documents we send to you through your DocuSign user account for a limited period of time (usually 30 days) after such documents are first sent to you. After such time, if you wish for us to send you paper copies of any such documents from our office to you, you will be charged a \$0.00 per-page fee. You may request delivery of such paper copies from us by following the procedure described below.

Withdrawing your consent

If you decide to receive notices and disclosures from us electronically, you may at any time change your mind and tell us that thereafter you want to receive required notices and disclosures only in paper format. Consequences of changing your mind

To indicate to us that you are changing your mind, you must withdraw your consent using the DocuSign 'Withdraw Consent' form on the signing page of your DocuSign account. This will indicate to us that you have withdrawn your consent to receive required notices and disclosures electronically from us and you will no longer be able to use your DocuSign Express user account to receive required notices and consents electronically from us or to sign electronically documents from us.
