Fall Semester:	<b>April 1</b>
Spring Semester:	<b>October 15</b>
Summer Semester:	<b>February 1</b>

Students must apply to the Undergraduate Admission one semester prior to completing their studies at Clark State College.

In order to be admitted fully as a business major at Wright State, students will need to achieve a cumulative GPA of a 2.5.
